This will allow enough time for you to receive your approval letter (if you are deemed eligible) before you need to buy your monthly pass. Eligibility and program funding is not guaranteed. If you're accepted to the program, you will receive a letter of authorization. Once you are authorized, purchase your first monthly pass and mail us your receipt to receive a 50% reimbursement. You can complete the same form on our website at www.hudsontma.org

Please be advised that the program may end at anytime and that there may be a limit as to the total amount of discounts provided per work site.
